BARRABA MEAT BREED SHEEP YOUNG JUDGING COMPETITION

Notes: All entrants need to be 15 to 25 years of age on 1 April 2019.

Prize money and ribbons will be given for 1st, 2nd and 3rd

All participants will number the sheep in front of them from A – D. In doing so, they will need to give their reasons for making their order. This is done on paperwork provided. All participants will have 8 minutes to assess the sheep and then a further 4 minutes to write, after which they will need to hand in their paperwork to the steward. Entrants will give a 2 minute talk on their order and why. From this the results will be finalized.

Group 13 meat breed, merino sheep & fleece, beef cattle, grain, fruit & veges finals will be held in Armidale at 9am on Sunday 10th March 2019. Contact Kelso Looker on **0429 359 320** or email **klooker42@gmail.com**. Group competitors need to be aged from 15 – 25 years as at 1st May 2019. Entrants need not have entered or won a class at the Barraba Show.

PLEASE READ REGULATION CHANGE - 10th May 2017

Once a competitor has qualified to represent a Group at Sydney Royal Show in any one of the Judging or Parading Competition State Finals, he/she may not enter another Group Final as a potential qualifier in that type of competition **WITHIN THAT COMPETITION YEAR**. He/She can, however, enter any one or more Group Finals anywhere in the state, for practice (and score), in the same type of competition as one in which he/she has previously qualified as long as he/she discloses this to the Group Final organizers at the time of entry and indicates that he/she is not eligible for a placing in that event. ("qualified" means First in Merino Sheep, First or Second in Meat Breeds Sheep, Merino Fleece and Beef Cattle, and First, Second or Third in Dairy Cattle, Fruit and Vegetables and Grain. The Stud Merino Breeders Association competitions in Merino Sheep Judging at Armidale, Canberra and Dubbo are classed as Group Finals. Beef Paraders as per scaling system.)

EXHIBITORS PLEASE NOTE

We are a Biosecurity Aware Show:

The Barraba P.A & H. Association Inc. is aware that biosecurity is an important issue when you consider exhibiting your livestock at our show. We have endeavoured to provide an environment that is as pest and disease free as possible in a show environment. However, while we continue to try to provide a safe environment for our exhibitors, you are ultimately responsible for your own biosecurity. You should make your own risk assessment of our facilities and act accordingly. Please use common sense.

The following advice from Animal Health Australia may help you make valid decisions – Responsibility for biosecurity doesn't end when your livestock leave the farm gate. By implementing good management practices in your farming operation, you'll be playing an important role in protecting your region, and possibly the entire industry, from devastating disease outbreaks. These practical measures will help ensure your biosecurity practices extend into the wider community:

Moving animals off your property -

- Make sure your animals are fit to travel before loading. Diseased/injured animals should not be moved off property and if necessary you should seek veterinary attention.
- Supply a NVD/TSS and animal health declaration

Taking animals to shows –

- Ensure pens/housing areas are clean before they enter
- Feed and water your livestock separately, if possible
- Never share equipment – if you must, always clean & disinfect before and after use
- Isolate any returning stock for 10 days to allow for weed seed elimination and signs of diseases and pests

- Dogs to be vaccinated for Parvovirus.

JOHNE'S DISEASE: Exhibitors will be required to have a signed Sheep Health Declaration. All competitors and exhibitors are asked to abide by the Association Rules and Regulations posted at the Secretary's Office.

All exhibitors and competitors are advised to hold their own public liability insurance policy. Exhibitors in all Sections participate and exhibit at their own risk and are required to sign a waiver form to include with entries.

Exhibitors are kindly requested to have their Entry Forms, Waiver Forms and Fees to the Steward or Secretary as early as possible.

Exhibitors are kindly requested to advise the Secretary at least three days prior to the Opening Day of the Show if they do not intend exhibiting the exhibits they have entered.
